

# ATFX AT GO Next-Gen Trading Power Promotion

October - December 2025



### Introduction

AT Global Markets LLC is a Limited Liability Company in Saint Vincent and the Grenadines with company number 333 LLC 2020. The Registered Office: 1st Floor, First St. Vincent Bank Bldg, James Street, Kingstown, St. Vincent and the Grenadines.

ATFX is running the "ATFX AT GO Next-Gen Trading Power Promotion" (hereinafter referred to as the "Promotion") and invites all Clients of ATFX in the Philippines, Malaysia, Vietnam, Thailand, Taiwan, South Korea, Singapore, Myanmar, India and Indonesia to participate. By participating in this Promotion, you agree to be bound by the Terms and Conditions herein (hereinafter referred to as the "Terms") as these are set out below.

# 1. Interpretation of Terms

### 1.1 In this Promotion:

"Account" shall mean a Client's MT5 trading account with ATFX into which the Client registers and deposits within the Promotion Period a Minimum Deposit;

"Minimum Deposit" shall mean a deposit of at least US\$100 or equivalent, made in the AT GO Mobile App. All accounts shall be enabled and/or approved for trading provided they comply with the eligibility criteria of clause 2.1.

"Promotion Period" shall mean from the 1 October 2025 (00:00) to the 31 December 2025 (23:59) (inclusive).

"Standard Terms of Business" shall mean the Terms and Conditions entered into by the Client and ATFX that govern all trading activity of the Client with ATFX.

"Cash Rebate" shall mean the USD 50 rebate which the Client who participates in the Promotion will be eligible to receive after meeting the Trade Requirement.

**"Trade Requirement"** shall mean trading a minimum of 10 lots of Energies, FX or Precious Metal products in the AT GO Mobile App. Only positions that were opened and closed during the promotion period will be eligible for this Campaign.

- 1.2 Any words whose meaning is not defined herein shall have the meaning provided in the Standard Terms of Business.
- 1.3 Times mentioned herein shall mean GMT +8 as applicable.

# 2. Eligibility Criteria

- 2.1 To participate in this Promotion, you must meet the following requirements:
  - a) You are a new or existing MT5 Client of ATFX from one of the eligible regions listed above, to trade in accordance to, and have agreed to, the Standard Terms of Business;
  - b) ATFX is entitled to verify the data of the Client by requesting from the Client presentation of phone, email and proper documents which would confirm: the address being entered in the proper register, authorization to represent the natural person or organization unit, as well as to enter into obligations on his/her behalf for a person registering to the ATFX Account, and contact data such as phone number or email address;



- c) Read and Accept the Terms of this Promotion;
- d) Make the Minimum Deposit of US\$100 via the AT Go Mobile App during the Promotion Period:
- e) Complete the Trade Requirement of 10 lots in the AT GO Mobile App during the Promotion Period;
- f) Irrespective of the number of trading accounts that a Client may run with ATFX, the Promotion is only applicable for new or existing Clients using one account under one identity. Each natural person can register for this promotion once only.

### Example 1:

Mr. A is an MT5 client who deposited US\$100 in the AT GO Mobile App on 10 October 2025, having accepted the Terms. He is eligible for the USD 50 cash rebate after trading 10 lots. Mr. A completed the 10 lots and made a profit of US\$200. His total available funds for withdrawal are US\$350.

Outcome: US\$100 deposit + US\$200 profit + USD 50 cash rebate

# Example 2:

Mr. B is newly registered a MT5 account and participates in both "ATFX AT GO Next-Gen Trading Power Promotion" & "ATFX 50% Credit Bonus Promotion". He made the first-time deposit of US500 from the AT GO Mobile App on 8 October 2025.

He is eligible for a 50% credit bonus of US\$250 plus the USD 50 cash rebate after completing the trading requirement of 50 lots through AT Go Mobile App. Mr. B traded 50 lots on 15 October 2025 and made a profit of US\$300. His credit bonus is now withdrawable. Including the cash rebate, Mr. B's total available funds for withdrawal are US\$1,100.

Outcome: US\$500 deposit + US\$300 profit + US\$250 credit bonus + USD 50 cash rebate

### 3. Duration

3.1 The Promotion Period starts from 1 October 2025 (00:00) to 31 December 2025 (inclusive).

## 4. Specific Program Terms

4.1 The Promotion is applicable to Energies, FXs, Precious Metal Products only, excluding share CFD and cryptos.

4.2 The Promotion is applicable to the MT5 account only.

4.3 The Cash Rebate will only be credited once the Trade Requirement in the AT GO Mobile App has been fully completed. No partial cash rebates are awarded if the Trade Requirement is not met.



- 4.4 The Cash Rebate shall be credited to the Client's account by the account manager or sales personnel.
- 4.5 Only positions that were opened and closed in the AT GO Mobile App within the Promotion Period after making the minimum deposit to join the promotion will be counted as lots traded.
- 4.6 All the trading activity must be completed in the Account within 90 days after making the first minimum deposit to join the promotion.
- 4.7 Transfers between accounts are not considered as deposits for the purposes of participating in this Promotion.
- 4.8 The clients cannot participate in the other promotion campaigns in the meantime, except for the "ATFX 50% Credit Bonus Promotion".

### 5. Miscellaneous

- 5.1 In the event that any dispute and/or misrepresentation is made in relation to the above applicable Terms, such dispute and/or misrepresentation shall be resolved by ATFX, acting in good faith and as it shall, in its sole and absolute discretion, be deemed fit and proper. ATFX'sdecision shall be final and binding.
- 5.2 ATFX has the right at any time and its absolute discretion to disqualify any Client who participates in the Promotion and/or withdraw with immediate notice the Cash Rebate and/or Credit Bonus and/or any profit gained if:
  - (a) A breach of these Terms and/or any term of the Standard Terms of Business occurs;
  - (b) ATFX has reasonable grounds to believe there is a valid misuse of this Promotion;
  - (c) The Client acts in bad faith and/or abusively and/or fraudulently and/or in a manner thatis not in line with this Promotion and its applicable Terms.
- 5.3 If any clients introduced to ATFX by Introducing Brokers misuse of this Promotion to gain the welcome bonus, the commission to the relevant Introducing Brokers would be cancelled.
- 5.4 ATFX shall not be held liable for any margin call or losses that the client may suffer, including but not limited to losses due to Stop-out Level, if the Cash Rebate or Credit Bonus is withdrawn for any reason pursuant to the Terms and Conditions set out herein.
- 5.5 ATFX has the right to alter these Terms at its absolute discretion and to suspend and/or terminate the Promotion if its continuation is rendered impossible due to extraordinary circumstances beyond the control of ATFX (natural disasters, political conflicts etc.).
- 5.6 Notwithstanding the translated language of this document, the English wording shall be the binding version in the event of any discrepancy between the two languages.
